Finance & Operations Committee Meeting Summary October 4, 2018 9:32 a.m.

These actions were taken by the Finance & Operations Committee on August 30, 2018:

Motion to approve the August 30, 2018 Finance & Operations Committee meeting minutes was made by Rep. Nicholas Duran and seconded by Steve Hope. Motion passed unanimously, 5-0.

Resolution 2019-A: Motion to recommend the resolution to the Board of Directors on October 22, 2018 was made by Steve Hope and seconded by Dr. Magaly Abrahante. Authorization to enter into a service agreement with Actors' Playhouse at the Miracle Theatre Inc., for co-production and presenting sponsorship of the Young Talent Big Dreams talent search, in an amount not to exceed \$50,000.00 for a term of 12 months, commencing on October 1, 2018, and ending on September 30, 2019. Motion passed, 4-0. Recusal by Mark Trowbridge

Resolution 2019-B: Motion to recommend the resolution to the Board of Directors on October **22, 2018** was made by Mark Trowbridge and seconded by Steve Hope. Authorization to enter into a third and final agreement with Schermer Creative Group, Inc., an agency selected from the 2016-2019 vendor pool for the purpose of providing six videos for the 2019 Champions for Children awards ceremony for an amount not to exceed \$30,000.00, and for regular and ongoing English/Spanish translation services being provided by the agency for \$8,000.00, in a total amount not to exceed \$38,000.00 for a term of 12 months, commencing on October 1, 2018, and ending on September 30, 2019. **Motion passed unanimously, 5-0.**

Resolution 2019-C: First motion to recommend the resolution to the Board of Directors on October 22, 2018 was made by Steve Hope and seconded by Mark Trowbridge. Authorization to release a request for proposals (RFP) for print services for *Parenting Our Children*, The Children's Trust's monthly parenting newsletter, for a total amount not to exceed \$55,000.00. Motion passed unanimously, 5-0. Second motion to amend the resolution to reflect "Authorization to release a request for qualifications (RFQ) was made by Steve Hope and seconded by Rep. Nicholas Duran. Motion passed unanimously, 5-0. Final motion was made by Mark Trowbridge and seconded by Dr. Magaly Abrahante. Motion passed unanimously, 5-0.

Resolution 2019-D: Motion to recommend the resolution to the Board of Directors on October 22, 2018 was made by Steve Hope and seconded by Rep. Nicholas Duran. Authorization for the expenditure of dues for membership in the Florida Children's Council, Inc. (FCC) in a total amount not to exceed \$132,513.00 for a term of 12 months, commencing October 1, 2018 and ending September 30, 2019. Motion passed unanimously, 5-0.

Resolution 2019-E: Motion to recommend the resolution to the Board of Directors on October 22, 2018 was made by Steve Hope and seconded by Mark Trowbridge. Authorization to negotiate and execute a contract with CypherWorx, Inc. to utilize its Learning Content Management System (LCMS) for online learning content and reporting in a total amount not to exceed \$50,000.00, commencing October 1, 2018 and ending September 30, 2019. **Motion passed unanimously, 5-0.**

Resolution 2019-F: Motion to recommend the resolution to the Board of Directors on October 22, 2018 was made by Steve Hope and seconded by Rep. Nicholas Duran. Authorization to enter into agreements with the Agency for Healthcare Administration (AHCA) on behalf of three school health providers, to draw down \$4,523,234.00 of Low Income Pool (LIP) funding by providing a local match and reducing the three school health providers' funding awards in a combined total amount of \$2,587,312.00. Motion passed unanimously, 5-0.

Resolution 2019-G: Motion to recommend the resolution to the Board of Directors on October 22, 2018 was made by Steve Hope and seconded by Mark Trowbridge. Authorization to negotiate and execute a contract with Healthmaster Holdings LLC for a software as a service solution to track school-based health clinic interactions, in a total amount not to exceed \$250,000.00, commencing October 1, 2018, and ending September 30, 2019, with four possible 12-month renewals. Motion passed unanimously, 5-0.

Background: The Children's Trust released a request for qualifications (RFQ), #2017-05, on November 21, 2016. Of the six applicants who responded to the RFQ, Branger+Briz, Inc. (Branger+Briz) was initially selected for this contract in 2017. Branger+Briz is recommended for a third contract renewal because of its efficiency, professionalism and talent in executing The Children Trust's digital footprint redesign. This contract will represent the continuation of work described herein, part of which was projected to be completed during FY 2017-18 but was delayed due to a shift of internal resources to support a successful solicitation release and contract execution.

Description of Services: Branger+Briz will continue to develop mobile-friendly digital solutions that easily integrate various platforms used by The Children's Trust. Doing so will further the programmatic reach and impact of The Children's Trust, as well as provide a route for direct feedback from parents and program participants. We also expect the increased access to improve overall data quality and availability. This phase of the digital footprint redesign will include, but is not limited to:

• Developing a new and more advanced mobile application.

This will help parents better access programs and tailored, relevant information (including age-appropriate parenting tips and children's book reviews) from wherever they are through their mobile devices; search and register their children for Trustfunded programs directly through the app; calendar events; connect through social media; permit The Children's Trust to push messages, notifications and information to those who have downloaded the app for direct two-way communication with end users of programs and services; and build our database of subscribers.

• Enhancing features and functionality of The Children's Trust's websites.
